Bending Toward Justice

The Birmingham Church Bombing that Changed the Course of Civil Rights

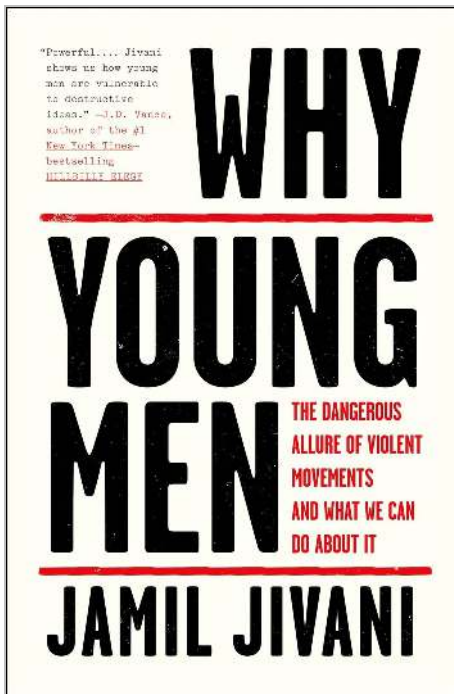
The story of the decades-long fight to bring justice to the victims of the 16th Street Baptist Church bombing, culminating in Sen. Doug Jones' prosecution of the last living bombers.

On September 15, 1963, the 16th Street Baptist Church in Birmingham, Alabama was bombed. The blast killed four young girls and injured twenty-two others. The FBI suspected four particularly radical Ku Klux Klan members. Yet due to reluctant witnesses, a lack of physical evidence, and pervasive racial prejudice the case was closed without any indictments.

But as Martin Luther King, Jr. famously expressed it, "the arc of the moral universe is long, but it bends toward justice." Years later, Alabama Attorney General William Baxley reopened the case, ultimately convicting one of the bombers in 1977. Another suspect passed away in 1994, and US Attorney Doug Jones tried and convicted the final two in 2001 and 2002, representing the correction of an outrageous miscarriage of justice nearly forty years in the making. Jones himself went on to win election as Alabama's first Democratic Senator since 1992 in a dramatic race against Republican challenger Roy Moore.

Bending Toward Justice is a dramatic and compulsively readable account of a key moment in our long national struggle for equality, related by an author who played a major role in these events. A distinguished work of legal and personal history, the book is destined to take its place alongside other canonical civil rights histories like *Parting the Waters* and *Mississippi Burning*.

DOUG JONES is a US Senator who has made finding common ground a hallmark of his tenure. In 2017, he became the first Democrat to win a Senate election in Alabama since 1992. As U.S. Attorney for the Northern District of Alabama from 1997 to 2001, JONES prosecuted two former Ku Klux Klan members for their roles in the racially-motivated 1963 16th Street Baptist Church Bombing that took the lives of four girls. He also secured an indictment against Centennial Olympic Park bomber Eric Rudolph.



Why Young Men

The Dangerous Allure of Violent Movements and What We Can Do About It

Across the world, we see an explosion of unpredictable violence committed by alienated young men.

Youth activist Jamil Jivani recounts his experiences working with angry and alienated young men throughout North America and the Middle East, drawing striking parallels between ISIS recruits, gangbangers, and Neo-Nazis in the West.

Having narrowly escaping a descent into crime and gang violence in his native Toronto, Jivani has devoted his life to helping other at-risk youths avoid this fate in cities across North America. After the Paris terrorist attacks of 2016, he traveled to Europe and the Middle East to assist Muslim community outreach groups focused on deterring ISIS recruitment.

Wolf Cubs is the story of Jivani's education as an activist on the front lines of one of today's most dangerous and intractable problems: the exploding violence among angry young men all over the world. Jivani relates his personal story and describes his entrance into the community outreach movement, his work with disenfranchised people of color in North America and at-risk youth in the Middle East and Africa, and his experiences with the white working class. The reader learns along with him as he profiles a diverse array of young men and interviews those who are trying to help them, drawing parallels between these groups, refuting the popular belief that they are radically different from each other, and offering concrete steps toward countering this global trend.

Inside the Fight to Save Press Freedom in the Age of Alternative Facts

David McCraw

David McCraw recounts his experiences as the top newsroom lawyer for the *New York Times* during the most turbulent era for journalism in generations.

In October 2016, when Donald Trump's lawyer demanded that *The New York Times* retract an article focused on two women that accused Trump of touching them inappropriately, David McCraw's scathing letter of refusal went viral and he became a hero of press freedom everywhere. But as you'll see in *Truth in Our Times*, for the top newsroom lawyer at the paper of record, it was just another day at the office.

McCraw has worked at the *Times* since 2002, leading the paper's fight for freedom of information, defending it against libel suits, and providing legal counsel to the reporters breaking the biggest stories of the year. In short: if you've read a controversial story in the paper since the Bush administration, it went across his desk first. From Chelsea Manning's leaks to Trump's tax returns, McCraw is at the center of the paper's decisions about what news is fit to print.

In *Truth in Our Times*, McCraw recounts the hard legal decisions behind the most impactful stories of the last decade with candor and style. The book is simultaneously a rare peek behind the curtain of the celebrated organization, a love letter to freedom of the press, and a decisive rebuttal of Trump's fake news slur through a series of hard cases. It is an absolute must-have for any dedicated reader of *The New York Times*.

DAVID MCCRAW is Deputy General Counsel at *The New York Times*, where he has worked since 2002. He provides legal counsel to the newsroom regarding libel, freedom of information, court access, litigation and news-gathering. Previously, he was Deputy General Counsel of *The New York Daily News*. He conducts workshops and performs pro bono work for freedom of press and information around the world. He is an adjunct professor at the NYU School of Law and a visiting lecturer at Harvard Law School.

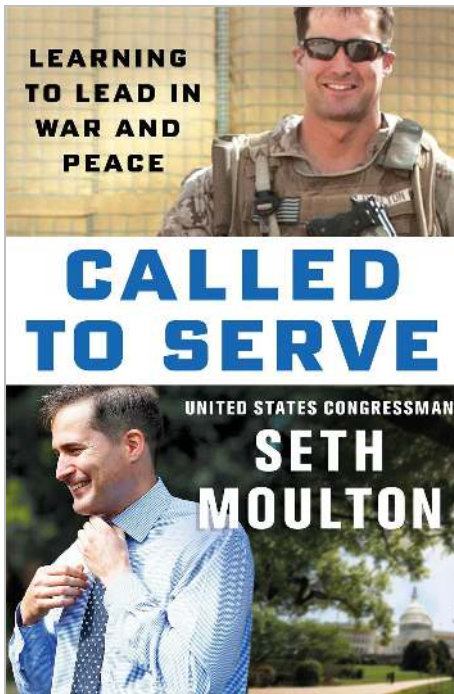

Learning to Lead in War and Peace

Seth Moulton

Marine veteran and Democratic Rep. Seth Moulton recounts his experiences in Iraq and on Capitol Hill, and calls for a program of national service to bring Americans together again.

Seth Moulton grew up in Massachusetts and graduated from Harvard, but he didn't follow his classmates to Wall Street; he joined the U.S. Marine Corps, a choice that shocked his liberal friends and family.

Like most Marines, Moulton signed up to prove something to himself. But discussions with his mentor, the Rev. Peter Gomes, about the importance of service to country and community also influenced his decision. A few months later, the 9/11 attacks dramatically changed the course of his life. He led an infantry platoon into Baghdad during the 2003 invasion of Iraq. In 2004, he experienced the fiercest fighting of the war to date: the block-by-block battle to dislodge the Mahdi Army from Najaf. He served four tours in Iraq, ultimately working for Gen. David Petraeus to develop counterinsurgency strategies and negotiate agreements with Shia tribes.

This is a story of service: how Moulton came to appreciate its importance, how the training, success, and failure he endured in the Marine Corps transformed him as a leader, and how his fellow Marines changed his life. This same call drove him to run for Congress, where he works to foster bipartisan leadership and develop a serious long-term strategy for the Middle East. This deeply felt and inspirational book is a testament to the enduring strength and value of the ideals that unite us as a people.

Congressman SETH MOULTON was born and raised in the Sixth District of Massachusetts. He attended public schools followed by Phillips Academy Andover and Harvard University, with help from student loans that he is still paying back. After graduating from Harvard in 2001, Seth served four tours in Iraq as a Marine Corps infantry officer. He has been a member of Congress since 2014, where he sits on the House Armed Services Committee and Budget Committee, and advocates for increased bipartisanship.
